To write an APA-style paper, use a 12-point font size, double spacing, and 1-inch margins all around. You should also include a title page with the title of your paper and your name and institution. Also, include a page header at the top of every page that gives a brief synopsis of your paper's title in under 50 characters.

The text should be typed on standard 8.5" x 11" white paper. The APA style requires using an easy-to-read font, recommending size 12, Times New Roman font. Double spacing is required on both the title page and throughout the paper. Margins should be 1" on all sides of the page.

All numbers in your Abstract should be typed as digits rather than words, except those that begin a sentence. Body. The body of your research paper begins on a new page, Page 3. The whole text should be typed flush-left with each paragraph's first line indented 5-7 spaces from the left.

An APA paper has three parts: The Title Page. The Essay. The Reference List. If your instructor would like an abstract, you can insert it after the title page. It's best to separate each section with a page break (Insert > Page Break).

Do not indent any part of the text. Double space the text. Use Times New Roman font in 12 pt. Set one-inch (or 2.54 cm) margins. If you include a “keywords” section at the end of the abstract, indent the first line and italicize the word “Keywords” while leaving the keywords themselves without any formatting.
